Item I bequeath unto My Loving friend Emanuel Bichi his ~~Heirs, Executors or Administrators~~ all My Wearing Apparel, Bed, Household & Kitchen furniture for his or their Use for Ever

Item all the Remainder of My Cash if any Remains after the above Legacy, Debts, & Funeral Expences are paid I bequeath unto My Son George Bissman, his Heirs, Executors or Administrators for his or their Use

~~Lastly~~ I appoint My Loving friend Adam Premis of the City of Philadelphia to be the Executor of this my Last Will & Testament, Revoking all former Wills & Testaments by me made & declare this to be my Last Will & Testament, Signed this Death Day of August One Thousand Seven Hundred & Ninety Six
